The Certified Member is responsible for keeping track of the requirements needed to maintain certification. Once a certified individual is delinquent in any requirement, they will be notified by AETA and have one year to correct the delinquency. If not corrected the individual will lose their status as an AETA Certified Member. It will be updated on the website and USDA APHIS will be notified. At that point, the individual must reapply and pass the certification exam to regain certification status.
